CAPE IS COMMITTED TO THE PROTECTION AND promotion of human health by addressing issues of local and global environmental degradation.

CAPE Activities

CAPE, ALONG WITH THE ONTARIO COLLEGE OF Family Physicians and the Canadian Environmental Law Association, established the Children's Environmental Health Project, an educational web site for health professionals and their patients <www.cape.ca/Children/index.html>.

THE CAPE HEALTH PROTECTION TRANSITION Project monitors changes in environmental health protection at Health Canada and educates officials on how best to protect the health of children and others.

TOGETHER WITH POLLUTION PROBE, CAPE organized a Children's Environmental Health Forum in November 2000, bringing together experts to describe how children differ from adults and how this should affect health and environmental standards.

CAPE HAS ESTABLISHED STRONG LINKS WITH organizations concerned about toxic substances and Genetically Modified Organisms (GMOs), including the Pesticide Action Network of North America (PANNA) and Canadian Organic Growers (COG).

PARTICIPATION IN THE WALKERTON INQUIRY will help CAPE ensure that water safety standards protect all citizens and that government cutbacks do not endanger the health of Canadians.

CAPE COORDINATED THE LAUNCH OF THE National Coalition for Green Health Care at an October 2000 workshop funded by Health Care Without Harm and Great
